Paczkowski, highly respected by her peers, gets most of her clients through referrals, a testament to her problem-solving skills and judgment. She prides herself on her empathy, trying to protect her clients' interests as they undergo some of the most stressful, challenging times of their lives.

Widely regarded as a model legal leader, Paczkowski devotes her spare time to mentoring young lawyers and giving back to the community. She was recently appointed by Gov.
