In 2019, this piece, which analyzed the ethics of the lawyers depicted in some of the world's most popular legal television programs, won the Smith-Doheny Legal Ethics Writing Competition, a nationally recognized contest sponsored by Notre Dame Law School. It was also later published on the New England Law Review Forum.
