# Solving a dispute with a dissident shareholder

Mike recently advised a public company's board of directors regarding its relationship with a dissident shareholder. "The shareholder had an objective which the majority of the board determined was not in the company's interest," Mike explained, "and was insisting on certain privileges to which he was not entitled." The company ultimately negotiated a settlement by which the dissident's shares were sold.

### Mediating between a foundation and its founder

When the founder of a large, private foundation alleged that the foundation was making grants beyond its stated objectives, Mike mediated an agreement whereby the founder withdrew his objections and was engaged by the foundation as an informal advisor.
